

## **End User Software License Agreement**

Welcome to the wonderful world of flightsim! BSMP is proud to provide you with what is reputed to be the best SAAB 2000 package available to flight-simmers like you. **This agreement is a legally binding contract that should be read in its entirety BEFORE using the product. Use of the product implies validation of this agreement.**

The BSMP SAAB 2000 is a virtual aircraft made from scratch by the BSMP team, as a FREEWARE add-on intended for use with Microsoft Flight Simulator 2004 (A Century of Flight).

### 1. License Agreement.

a. The BSMP SAAB 2000 (the "aircraft"), any repaints downloaded with the aircraft package (the "Liveries"), and any other software or services you elected to download with this package (such as Manuals etc...), and the related documentation, local computer files installed by the installer application and any upgrades, enhancements, modifications, updates, revisions, and substitutions thereto (collectively the "Software"), are owned by Blu-Sky Mine Productions. ("BSMP") or its licensors and content and data providers ("Licensors"). Except as otherwise expressly set forth herein, the Software is licensed to you on a worldwide, non-exclusive, non-sub-licensable basis on the terms and conditions set forth herein. This License Agreement defines legal use of the Software and any copies of the Software made by or for you. All rights not expressly granted to you are reserved by BSMP, Licensors, or their respective owners.

b. Subject to the terms of this License Agreement, YOU MAY install and personally use the Software provided by BSMP, or those licensed to distribute it (in their sole discretion) on a personal computer owned or controlled by you and may use the Software for your own noncommercial use or benefit. Your license to the Software under this License Agreement continues until it is terminated by either party. You may terminate the License Agreement by discontinuing the use of the Software and uninstalling it. This License Agreement terminates automatically if you (i) violate any terms of this License Agreement, (ii) BSMP publicly posts a written notice of termination on the BSMP web site, or (iii) BSMP sends a written notice of termination to you.

c. YOU MAY NOT redistribute any accessible programming or design contained within the software (specifically including, but not limited to any images, sounds, flight dynamics, models and their respective code) without the explicit consent of a Senior member of the BSMP team.

d. Except otherwise explicitly stated, YOU MAY NOT:

(i) Decompile, reverse engineer, disassemble, modify, rent, lease, loan, distribute, or create derivative works or improvements (as per patent law) from the Software or any portion thereof.

(ii) Incorporate the Software into any computer chip or the firmware of any computing device.

(iii) Use the Software in any unlawful manner, for any unlawful purpose, or in any manner inconsistent with current law.

(iv) Use the Software to facilitate flight training, or other mission critical application where human life or property may be –directly or indirectly– at stake. You understand that the Software is

not designed for such purposes and that its failure in such cases could lead to death, personal injury, or severe property or environmental damage; for which BSMP is not responsible.

(v) use or export the Software in violation of applicable laws or regulations.

(vi) Sell, lease, loan, distribute, transfer, or sublicense the Software or access thereto or derive income from the use or provision of the Software, whether for direct commercial or monetary gain or otherwise, without BSMP's prior, explicit, written permission. Not gaining such permissions is punishable by law.

## 2. Ownership and Relationship of Parties.

The Software is protected by copyrights, trademarks, service marks, international treaties, and/or other proprietary rights and laws of many countries. You agree to abide by all applicable proprietary rights laws and other laws, as well as any additional copyright notices or restrictions contained in this License Agreement. BSMP and Licensors own all rights, title, and interest in and to their applicable contributions to the Software. This License Agreement grants you no right, title, or interest in any intellectual property owned or licensed by BSMP, including (but not limited to) the Software and BSMP trademarks, and creates no direct relationship between yourself and Licensors, or between you and BSMP other than that of licensor to licensee under this License Agreement.

## 3. Support and Software Updates.

BSMP may elect to provide you with customer support and/or software upgrades, enhancements, or modifications for the Software, in its sole discretion, and may terminate such Support at any time without notice to you. BSMP may change, suspend, or discontinue any aspect of the Software at any time, including the availability of the software in its entirety, or any Software content. BSMP may also impose limits on certain features and services or restrict your access to parts or all of the Software or the BSMP web site or forum without notice or liability.

## 4. Fees and Payments.

BSMP reserves the right to charge fees for future use of or access to the Software, although be assured that there is a very low possibility of such action being taken.

## 5. Disclaimer of Warranties by BSMP.

USE OF THE SOFTWARE AND ANY DATA ACCESSED THROUGH THE SOFTWARE IS AT YOUR SOLE RISK AND ARE PROVIDED "AS IS."

#### 8. Controlling Law.

This License Agreement and the relationship between you and BSMP are governed by British law, and the collective law of the US state of California - without regard to its conflict of law provisions. The United Nations Convention on the International Sale of Goods does not apply to this License Agreement.

#### 9. No General Waiver; Severability.

The failure of BSMP to exercise or enforce any right or provision of this License Agreement shall not constitute a waiver of such right or provision. If any provision of this License Agreement is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of this License Agreement remain in full force and effect.

#### 10. Complete Agreement.

This License Agreement and the Terms of Service ("TOS") constitute an entire understanding between the parties regarding respectful use of the Software, superseding all prior agreements between you and BSMP. In the event of any conflict between the terms and conditions of this License Agreement and those in the TOS, the terms and conditions of this License Agreement will control, except to the extent that the TOS impose additional restrictions and liabilities on your actions. In the event of a conflict between the terms of this License Agreement and the TOS, this License Agreement will control to the extent of such conflict.

Sections 1(d), 2, and 4 through 11, will survive any termination of this Agreement.
